EVENT FORMAT	Only IFAGG members in good standing can register participating groups. IFAGG WORLD CUP III (women category) Limit of 4 teams per country, 12 in final competition, max 2 teams per country.	

	IFAGG CHALLENGE CUP III (junior category) Limit of 4 teams per country, 12 in final competition, max 2 teams per country All gymnasts and coaches must have a valid IFAGG license for 2024.
COMPETITION AREA	Competition Carpet: 13mx13m-interior of the line on wooden floor.
TRAINING AREA	There will be a warmup zone in a separate hall.
	There will be 6 carpets behind the competition area.
ENTRY FEES	The non-reimbursable entry fee is:
	A group consisting of 1-6 gymnasts and max 2 coaches: 150€/ group. A group consisting of 7 or more gymnasts and max 3 coaches 180€/ group.
	Each team could have max 1 doctor and 1 other delegate.
	Extra accreditation over the limit of group number is 40 €/ delegate.
	Deadline for definitive registration: 29 th May
	According to IFAGG rules the registration after deadline will carry an additional charge of 100€ per group (to be paid to the LOC)
	The organizer will send you the invoice after your registration on the KSIS system.
	The entry fee is NON-REFUNDABLE.
