PERSONAL DATA PROTECTION	Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, rgform.eu online environment, competition's/federation's website and in social media channels. By registering, the gymnasts, coaches, judges and volunteers give consent to publish visual materials (photos, videos).In case the person is not consent with the previous, LOC and Federation has to be informed in written form by the start of the competition.		
MEDIA	Only photographers and journalists with accreditation are allowed to take pictures and film the event. (Registering via rgform.eu or onsite).		
ACCREDITATION	The Delegation will be accredited upon their arrival		
	During the accreditation Head of Delegations are required to:		
	Confirm the correct names spelling of their entire delegation,		
	Manage passport control of all gymnasts,		
	Provide proof of medical insurance of all delegation members,		
	Manage music check control,		
	Submit personal data protection declaration, Make and a second of the second of		
	Make any necessary payments. Approximation for of 155 per person will apply if delegation members.		
	Accreditation fee of 15€ per person will apply if delegation members do not stay at the official hotel.		
VISA INVITATION	All delegations requiring Visa must complete the visa request form (found in KSIS event) and send it to LOC by January 22, 2025 , latest.		
ACCOMMODATION	The hotel rooms will be allocated on a "first-come, first-served"		
	basis. The invited participating federations and clubs must pay for the accommodation expenses of their delegation members. The prices charged for the hotel rooms will not exceed the usual hotel rates. NF-s and clubs can book a hotel among the ones proposed via the LOC online KSIS platform. These rooms will be assigned strictly in order of booking receipt (first-come, first-served).
